In this regard we refer to the fact that the components identified by us below, to the extent that they come into contact with drinking water, fully correspond to the current "Evaluation criteria for metallic materials in contact with drinking water (Metall-Bewertungsgrundlage)" from the Federal Environment Agency as well as to the current "Acceptance of metallic materials used for products in contact with drinking water" from 4MS Common Approach. It is therefore self-evident that the continued safe use of the product is guaranteed. Please observe the usage instructions of the product.
